ARTICLE IV : POWERS OF THE TRUSTEES :

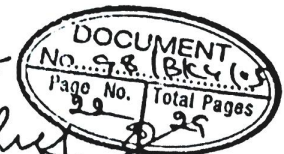

Section IV.2. Management of Trust Assets :

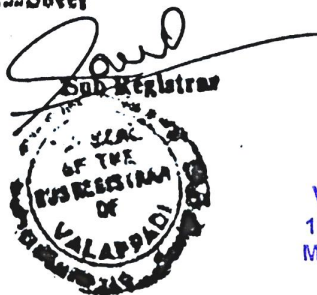
Without prejudice to the general powers given in Section IV.1. The Trustees shall have powers :
